## Timeline:

- Design proof on existing vector art provided in (1) business day.
- Embroidery DST file creation and stitch-out: (3-5) business days.
- Production (with design proof approval, quote approval, goods arrival, and account set up)
  - Standard turn-time: (5-7) business days contact your Customer Service Rep for scheduling
    - Rush timelines available (additional fees will apply)

• Ship turn-times may vary (2) weeks prior to major holidays and rush options will become limited during the following periods: (New Years, Memorial Day, July 4th, Labor Day, Thanksgiving, XMAS) Validate scheduled in-hand dates with your Customer Service Rep during these periods and plan early.

## Payment:

- Authorized credit card on file charged on the morning production begins
- Forms of payment: MC, Visa, and AX

(Notice: Unpaid or delinquent accounts are turned over to our Attorney for collection after 60 days. In this event, reasonable Attorney fees, interest and court-related fees will be added in addition to the remaining balance.)

## Design Proof Approval:

For best results view the design proof on a computer. Previewing design proof on a phone and/or tablet while possible, may limit your ability to see details. Design proofs are computer generated representations and may not proportionality match the final product. Small: ™, © may not be legible when printed or embroidered. Ensure to review and validate image dimension, placement position and color selection. We will apply standard location placement unless otherwise directed. Thoroughly review and approve the design proof. Ensure to validate spelling, proper names, acronyms, abbreviations, punctuation, hashtags, sponsor logos, image sizing, ink colors and that this is the correct version of the graphic before approving the design proof. Seaside Silk Screening will not be responsible for design proof errors or omissions overlooked by the customer on printed and embroidered apparel. Customer warrants that the subject matter to be screen printed, embroidered or otherwise decorated on garments, fabric or other mediums printed by Seaside Silk Screening is not copyrighted or trademarked. If the material is protected by copyright or trademark that the customer has obtained all the proper approvals and release documentation required to allow Seaside Silk Screening to decorate the material. Customer further warrants that no copyright and/or trademark notice has been removed from any material provided. Customer agrees to indemnify and hold Seaside Silk Screening, a division of Carolina Beach Apparel, LLC, harmless for all liability, damages, and attorney fees that may be incurred in any legal action connected with copyright and/or trademark infringement involving the work produced for the customer.

## Quote Approval:

Quote approval is the final step before we proceed to production, customer sign-off is critical and validates you have thoroughly reviewed the design proof, products, quantities, sizes, pricing and are ready for us to proceed into production.

## **Production Spoilage & Supply Chain Considerations:**

Allow for (2%) spoilage in production. Print/Embroidery runs under (100) units allow for (2) units. Spoilage/mill defects will be noted on your invoice and associated fees will be reduced accordingly. If each item is assigned to a wearer and the count is critical we encourage sourcing extra garments per size to avoid re-print costs from production spoilage or mill defects found at press time, we will include additional garments in the print run at no cost. Note: we count and Q/A sizing/color on receipt of your goods, however, Seaside Silk Screening will not be responsible for inspecting every garment for mill defects. Spoilage/mill defects will be noted on your invoice and associated print fees will be reduced accordingly. Customer supplied goods, inadvertently shipped/supplied to us without a corresponding order or return authorization and not reclaimed, will be automatically disposed of after six months from receipt.

## Shipping:

Customer authorizes Seaside Silk Screening to use their UPS and/or FEDX account to ship completed orders as directed. Customer is responsible for the entire cost related to shipment. Unpaid shipping fees that revert back to Seaside Silk Screening will be applied to a customer's credit card on file. Seaside Silk Screening will not be responsible for missed delivery dates caused by the shipping company or for inclement weather conditions.

## Finished Product Count & Production Seal:

Every order is counted/validated (3) times for accuracy:

- 1st time by the blank supplier
- 2nd time upon receiving the goods
- 3rd time in packing finished goods

Every completed order includes a production seal (per packed box) validating the count of goods in each box.
